Any notice that Daycare Deluxe or its representative may wish or be required to give to the father, mother, or guardian as stated in this document shall be considered duly given if such written notice is sent by prepaid registered mail, addressed to the father, mother, or guardian at the address provided by them in this agreement. Notice shall be considered received 7 (seven) days after dispatch by registered mail from any mail agency or post office in the USA. The certificate of posting of registered mail will serve as sufficient proof of the date on which such notice was dispatched.

The parties agree that this document constitutes the entire agreement between them, and that no alteration or change will be valid unless it is reduced to writing and signed by both parties.

# LEVY FOR LATE PAYMENT:

If the monthly daycare fee is received <u>after</u> the second workday of the month or if it is not received by Daycare Deluxe, then Daycare Deluxe, in addition to other legal remedies, may claim from the responsible parent/guardian a late payment fee equal to 10% of the overdue amount. This fee covers administration and other expenses.

In addition to the aforementioned, Daycare Deluxe reserves the right to refuse admission to a child at the daycare if any outstanding amount remains unpaid by the 3rd workday. Daycare Deluxe is also entitled, without further discussion between the contracting parties, to terminate this agreement with immediate effect as outlined herein, without incurring any additional legal obligations.

## **EXERCISE OF RIGHTS:**

- Each party hereby consents to the jurisdiction of the designated Justice of the Peace Court (JP) if any party initiates legal proceedings, notwithstanding that the amount claimed exceeds the jurisdiction of that court.
- The costs which any party is obligated to pay to the other party for the exercise of their rights under this agreement include legal costs based on the tariff between attorney and client, collection commission, and tracing fees.
- This agreement binds parent(s)/guardian(s) jointly and severally.
- The parent(s)/guardian(s) hereby confirm(s) and accept(s) the terms and conditions of this contract and acknowledge(s) that, <u>at their</u> <u>request</u>, the representative of Daycare Deluxe has explained it to their satisfaction.

### **Daycare Hours:**

Monday - Thursday: 6:45 AM - 6:00 PM Friday: 6:45 AM - <u>5:30</u> PM

- > The attendance register must be signed every day.
- Parents collecting their children after the agreed-upon time according to enrollment must send a message to the daycare informing us of the situation. The daycare center will then arrange to have the child supervised by a child minder at an additional minimum fee of \$16.00 for the first hour or part thereof and \$18.00 per hour or part thereof for any additional time.
- Only the international clock as displayed on a cell phone will be accepted to avoid disputes on observed time.
- The penalty must be paid the <u>next day</u> the child attends the daycare.
- Parents with any queries or requests regarding their children enrolled at Daycare Deluxe must contact the supervisor or director without delay. No teacher is authorized to accept any requests or instructions from a parent or guardian.
- Bulk communications with parents will only be done via the WhatsApp group created for parents for the specific year.
- Parents need to request the link for the WhatsApp group at the office.
- Breakfast is only served between 8:00 AM and 8:30 AM. No requests for late breakfast can be considered.
- Lunch is served between 12:00 PM and 1:00 PM.
- When applicable, parents must fill out the medication chart stipulating dosages and the time when medication is to be given.
- Medication containers are to be clearly labelled indicating the content and the name of your child.
- No medicine will be given to a child unless the medication chart has been completed and signed by the parent.

- All precautions will be taken to prevent any loss or damage to clothing. However, the daycare center does not accept responsibility if loss or damage to clothing does occur.
- Clothing must be clearly marked by the parent(s).
- No expensive jewelry (including earrings) and hair accessories are to be worn to the daycare center.
- his agreement is void if it is not signed by the parent or legal guardian who enrolled the child.
- This agreement is void if any alteration is made to any clause without the written consent of the Director of the daycare.
- Children should not bring their own toys to the daycare center as no responsibility for such toys can be accepted by the daycare.
- It is the responsibility of the parent(s) or guardian to update telephone numbers, email addresses, or any other details as provided herein.

# Medical conditions:

- Children that are infected with lice or a transmittable disease must be treated without delay and will not be allowed to attend the daycare unless a medical clearance certificate of such condition can be submitted if it is issued by a medical doctor.
- It is noted that Daycare Deluxe does not accept responsibility for the treatment of such conditions.
- > In the case of "head lice" infection we follow a "**no-nit policy**".
- In the case of "chickenpox" no scabs must be on any body part for a child to attend the daycare.
- Parents and/or guardians admit that they are aware of the risk that a contagious disease or sickness of any nature can be contracted by any child while attending the daycare and agree not to hold the daycare, the owner(s)/shareholders/members, or employees liable or responsible for any consequences of such an illness.

- \* Wet wipes as required for your child.
- \* A blanket for your child.
- \* Extra clothes and a sweater. (All items to be clearly marked)
- \* Milk in their own bottles, prepared for the day if still using a bottle.
- \* If necessary, a clean bib for the day.

### Extract of terms of this agreement:

The applicants:

- accept that the monthly fee is payable in advance on or before the 2nd workday of each month.
- agree to give one calendar months' notice in writing if the service as indicated is no longer required or to pay one month's fee in lieu of notice.

- agree to pay the levy for late payment, legal and collection fees on overdue accounts.
- Penalty payable in the case of late collection: A child will be supervised by a child minder at an additional minimum fee of \$16.00 for the first hour or part thereof and \$18.00 per hour or part thereof for any additional time.
- Penalty for late collection is payable irrespective of the reason for being late (traffic/transport, etc.)
- Any penalty to be paid the next day the child attends the daycare.
